Survey Results:

Dr. B: 786 survey responses in 2 days. Strongly oppose: 88.9%. Somewhat oppose: 6.3%. Dr. B has invited authorities and Murch principal/families to see the reality of Lafayette drop-off and pickup. She has given numbers to her counterparts: parking spaces, recess logistics, every kind of data.

DGS: Survey responses raised these types of issues:

Todd: Just became aware of the issue Saturday. "Continue to email the chancellor; continue to email the deputy mayor...This matter has my full attention and that of my staff."

- Split on-site at Murch and Capital Memorial Church
- UDC soccer field
- Lafayette
- Q. Why is Lafayette suddenly on the table?
- A. DGS: "DCPS newly asked us to consider it as an option and elicit feedback from community."
- Q. What is the Murch opposition to other options in the top four?
- A: DGS: "Murch community does not want the tight space and construction noise of trailers." (Room erupted in bitter yet empathetic laughter.)
- Q: "Several times you have said that this is not the cheapest option. Why would anybody want to do this if it's not to save a lot of money?"
- A. DGS: "The only real benefit is that it's built."
